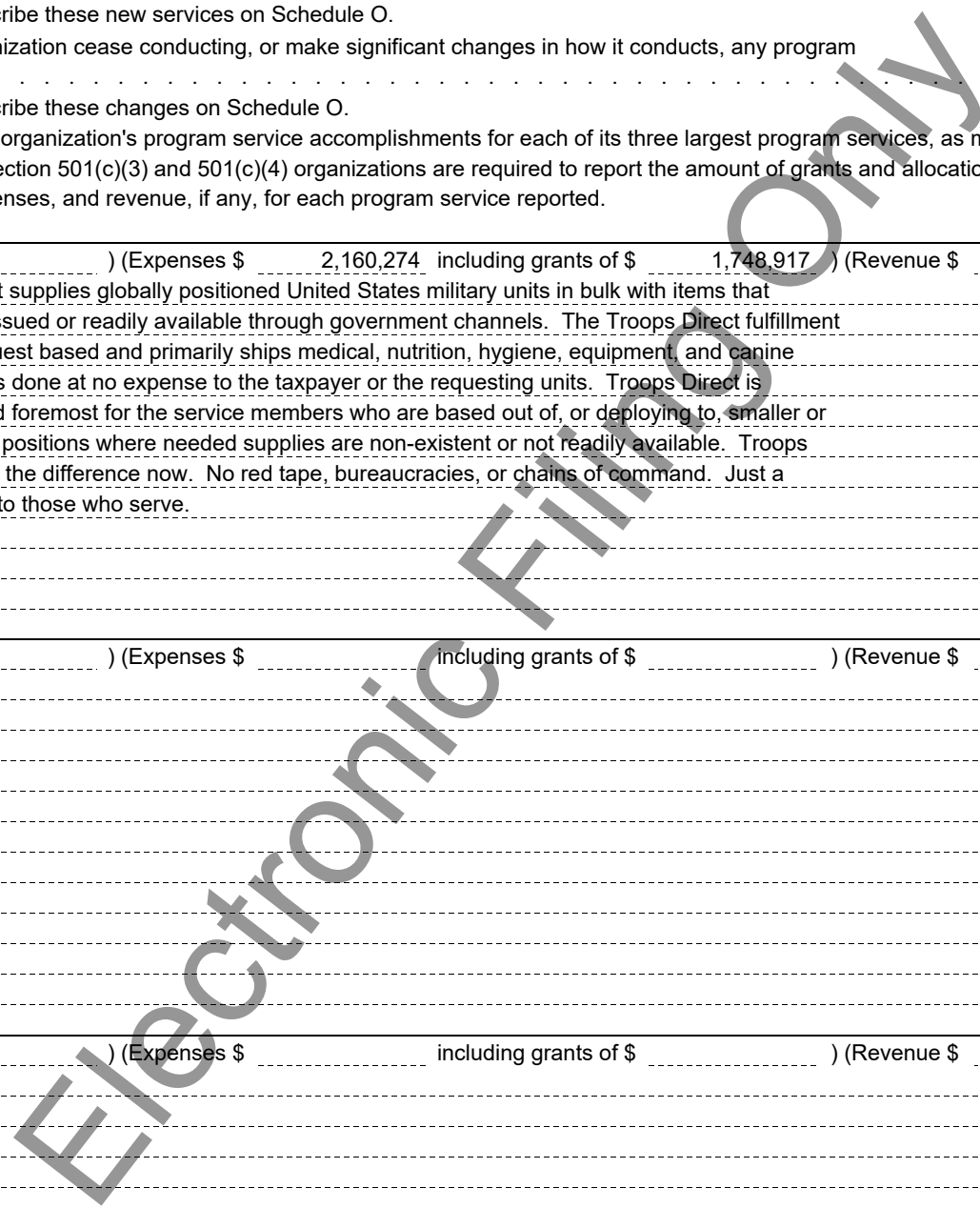

Troops Direct is there first and foremost for the service members who are based out of, or deploying to, smaller or more remote positions where needed supplies are non-existent or not readily available. Troops Direct makes the difference now. No red tape, bureaucracies, or chains of command. Just a commitment to those who serve.
